ADVOCATES ARE LOCATED IN THE COURTHOUSES USED BY THE 24 TOWNS INTERVAL HOUSE SERVES. ADVOCATES HELP VICTIMS UNDERSTAND THE JUDICIAL PROCESS, AID IN EVALUATING THEIR SITUATION AND DETERMINING THEIR PARTICULAR NEEDS, MOST IMPORTANTLY INCLUDING SAFETY PLANNING. ADVOCATES ALSO HELP VICTIMS DEVELOP A PLAN FOR MOVING FORWARD WITH THEIR LIVES AND ACCESSING ADDITIONAL RESOURCES NECESSARY TO ACCOMPLISH THEIR GOALS. ONE-ON-ONE CRISIS COUNSELING IS PROVIDED TO VICTIMS AND THEIR CHILDREN. THESE PROGRAMS ALSO INCLUDE THE OPERATION OF A 24/7 HOTLINE AND THE STATEWIDE 24-HOUR SPANISH CRISIS HOTLINE.

THE SHELTER IS IN A NON-DISCLOSED LOCATION AND CAN ACCOMMODATE UP TO 25 WOMEN AND CHILDREN AT A TIME. INTERVAL HOUSE ALSO WORKS WITH MEN AND EMERGENCY SAFE HOUSING IS PROVIDED ELSEWHERE FOR THOSE CLIENTS. INTERVAL HOUSE OPERATES A CRISIS HOTLINE FOR VICTIMS OF DOMESTIC VIOLENCE. THIS HOTLINE OPERATES 24 HOURS A DAY, EVERY SINGLE DAY OF THE CALENDAR YEAR. ALL PERSONS ANSWERING THE HOTLINE ARE CERTIFIED DOMESTIC VIOLENCE CRISIS COUNSELORS.
